Notice for Closure of Trading Window

Dear Sir/Madam,

Notice is hereby Given that as per the Company's Code of Conduct to Regulate, Monitor and Report Trading by Designated Persons and their immediate Relatives, framed pursuant to SEBI (Prohibition of Insider Trading) Regulation, 2015, for the purpose for the announcement of Financial Results for the quarter and period ended **30 September 2020** the Trading Window for dealing in shares of the Company will remain closed for all the Designated persons and their immediate relatives from **Thursday, 01 October 2020** until 48 (Forty-eight) hours after the announcement of the Financial Results of the Company for the quarter and period ending **30 September 2020**.

 - c. all the employees in Accounts, Finance, legal and Secretarial department;
 - d. All its promoters and promoters group;
 - a. All employees who have access to possession of Unpublished Price Sensitive Information.
 - e. Any other employee as may be determined and informed by the Compliance Officer from time to time;
 - f. Employees of Material Subsidiary companies of listed company designated as Manager and above;
 - g. Persons in contractual, fiduciary or advisory relationship with the Company i.e. consultants, retainers, auditors, law firms, analysts etc.
 - h. Other persons as designated by the Board of Directors in consultation with Compliance Officer of the Company, from time to time; and
 - i. Immediate relative of (a) to (h) above and have access to UPSI.

"immediate relative" means:

Spouse of a person, and includes parent, sibling, and child of such person or of the spouse, any of whom is either dependent financially on such person, or consults such person in taking decisions relating to trading in securities;

"Trading" means and includes subscribing, buying, selling, dealing (including pledging), or agreeing to subscribe, buy, sell, deal in any securities of the Company and "trade" shall be construed accordingly
